Director General at the Department of Finance

Fabrizia Lapecorella has been the Director General at the Department of Finance since 24th of June 2008.

In 1987 she graduated with honors in Economics and Commerce at the University of Bari, with a thesis on Finance and Financial Law. In the same

year she obtained a Certificate in Economics from the University of York (U.K.). In 1997 she obtained the title of Doctor of Philosophy in Economics from the University of York (U.K.).

From 12th of January 2004, she has been Full Professor of Public Finance.

From 2001 to 2007 she held various positions at the Ministry of Economy and Finance.

In 2002 she was appointed SECIT Expert (Tax Advisory and Inspective Service) and carried out her own activity within the International Relations Office of the Cabinet Minister and then within Fiscal Policies Tax Policy Department in the International Relations Office.

From January 2006 to October 2007 she was Director of Secit.

From 1st of January 2008 till 14th of June 2008 she was appointed General Director of the Observatory for public procurement- Market analysis and study at the Italian Supervisory Authority for Public Contracts.

She has been an Administration Counselor of Cassa Depositi e Prestiti since 24th of July 2018.

She has been Deputy Chair of Committee of Fiscal Affairs of OSCE and of the Inclusive Framework on BEPS implementation, from 2017 as also member of the Steering Group of the Inclusive Framework on BEPS implementation, since June 2016.

Since January 2012 she is member of the Bureau of the OECD Committee of Fiscal Affairs.

She has carried out research in the fields of economic analysis of taxation, public finance, public economics and contract theory. He has held courses at the Universities of Rome, Bari, York, Belgrano - Buenos Aires, as well as at the High School of Economics and Finance.











Laura Cavallo

Degree in Economics and Commerce from La Sapienza University of Rome; PhD in Economics of Institutions and Financial Markets at the Tor Vergata University: *Master of Science in Finance* at *Birkbeck College, University of London*. She served at the Faculty of Economics of the University of Rome Tor Vergata (from 1992 to 1999) with assignments of teaching and research.

She entered the public administration in 1999, at the MEF- Directorate for the Public Debt, since 2000 she has been a manager in the roles of the Council Presidency, where since 2016 she has served as Director of the Operational Planning Office within the Department for Cohesion Policies

In the Council Presidency she held duties within the Department for Economic Affairs, the Department for European Policies, the Technical Secretariat of the Minister for Regional Affairs and Local Autonomies, the Office of the Council Presidency and was head of the Technical Secretariat of the Undersecretary of State to the Council Presidency. He has spent periods of study and research at the following universities: Paris Dauphine (2009-10), University of York (2011-16), University of Portsmouth (2017-18). Since 2017 he is responsible for the Department of Finance of the Ministry of Economy and Finance of the projects Structural Reform Support Program - DG Reform funded by the European Commission and developed (from 2019) in collaboration with the World Bank and Ecomod.
